



# APPLICATION FOR PRIMARY REALTOR® MEMBERSHIP (from other Association)

In the event of my election, I agree to abide by the Code of Ethics of the National Association of REALTORS®, and the Constitution, Bylaws and Rules and Regulations of the above named Association, the State Association and the National Association. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate, all as from time to time amended. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as Code of Ethics training or Suburban West's Membership Renewal Training Requirement, not be completed within timeframe established in the Association's policies.

**NOTE:** Applicant acknowledges that if accepted as a Member and he/she subsequently resigns from the Association or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided that the dispute arose while applicant was a REALTOR®.

**CODE OF ETHICS REQUIREMENT and MEMBERSHIP RENEWAL TRAINING REQUIREMENT:** As of January 1, 2017, the National Association of REALTORS® requires that all REALTOR® members complete training on the Code of Ethics every 2 years. The current period for completing NAR's Code of Ethics is January 1, 2017 through December 31, 2018. As of January 1, 2009, the Suburban West REALTORS® Association requires that all Suburban West REALTOR® members complete Membership Renewal Training every 2 years on a topic as determined by the Association's Board of Directors. The current period for completing Suburban West's Membership Renewal Training requirement is January 1, 2017 through December 31, 2018. **All applicants for REALTOR® membership who have had a lapse in membership for more than one year must complete Code of Ethics training within 90 days of your application. Failure to complete this requirement may result in forfeiture of your application.**

# REALTOR® MEMBERSHIP APPLICATION POLICIES AND PROCEDURES

REALTOR® membership in the Suburban West REALTORS® Association, Pennsylvania Association of REALTORS® and the National Association of REALTORS® is a privilege provided to qualified licensees. The following document outlines the criteria for membership, policies that govern membership and the procedure for joining the organization.

## Membership Criteria

An applicant for REALTOR® membership should supply satisfactory evidence that he/she:

1. Has a valid Pennsylvania or a state contiguous to Pennsylvania real estate salesperson, broker or appraisal license and is actively engaged in the real estate business and its recognized branches.\*
2. Is employed by a REALTOR® or affiliated with a REALTOR® as an Independent Contractor.
3. Must make written application for REALTOR® membership in the Association.
4. Signified his/her intention to abide by the National Association of REALTORS® Code of Ethics.
5. Signified his/her intention to abide by the Constitution, Bylaws, Policy, and Rule and Regulations of the Local, State, and National Associations of REALTORS®.
6. Has completed an Association Orientation course.

**\*If an individual's license is pending, the applicant must provide a copy of the license application that was sent to the State. The application will subsequently be processed but the individual cannot attend New Member Orientation until the license is active.**

## Membership Policies

There are policies that govern the membership through both the Suburban West REALTORS Association and the National Association of REALTORS®. The following are the major policies of membership that all member applicants should be aware of:

- The Suburban West REALTORS® Association does not mandate that a real estate licensee become a Member of the Association. However, member firms may require Association membership as a condition of employment. Primary Designated REALTORS® will be billed, as part of their dues, for each non-member licensee in their office and/or firm.
- As of January 1, 2017, the National Association of REALTORS® requires that all REALTOR® members complete training on the Code of Ethics every 2 years. The current period for completing NAR's Code of Ethics is January 1, 2017 through December 31, 2018. **NOTE: If a re-applicant or previously with another association AND have had an absence of REALTOR membership for greater than a year, the applicant must complete Code of Ethics training within 90 days of the application being processed.**
- As of January 1, 2009, all Suburban West REALTOR members (both primary and secondary) must complete 2 ½ hours of required Membership Renewal Training on a topic agreed upon by the Association's Board of Directors. Completion of this requirement is needed every two years. The current period is January 1, 2017 through December 31, 2018 and FREE classes will be provided by the organization throughout the current period.
- REALTOR® members who fail to pay their annual dues within the allotted time will be dropped from membership and will be required to re-apply and pay a \$100 fee in order to be reinstated to full REALTOR® membership. If a licensee is made inactive for failure to pay dues and are still affiliated with a REALTOR office, the Designated REALTOR will be billed, as part of their dues, for the non-member licensee.

## Membership Dues

The membership year is defined as January 1 through December 31. **Licensees making application after January 31 submit prorated dues for the remainder of the year.** *NOTE: Applicants from another association who've not been members of the Pennsylvania Association of REALTORS must remit a \$100 PAR application fee with their dues payment.*

**\*Applicants who were previous REALTORS (with Suburban West or another Association) and have had a lapse of membership for 1 year must complete Code of Ethics training and Membership Renewal Training within 90 days of application. REALTORS® transferring their active membership from another REALTOR® Association are simply required to complete a membership application and pay the appropriate dues and fees.**

**\*\*Refunds: Local (SWRA), State (PAR) and National (NAR) dues are not refundable and not transferable.**
