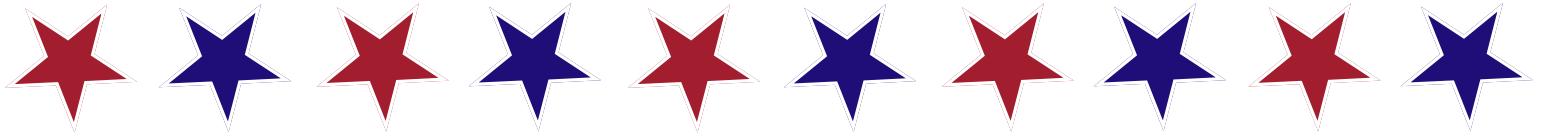

OFFICIAL RULES

To be eligible to win one (1) two-year lease for 2018 Toyota Highlander (valued at \$11,000) in the RPAC sweepstakes, please follow these rules:

1. You must be eligible to contribute to RPAC, a federal political action committee, in order to participate in the sweepstakes. The class of eligible contributors is comprised of REALTOR members, SWRA Affiliate members and their immediate family. SWRA and Suburban REALTORS Alliance staff, their immediate families, and those living in their households are not eligible for the sweepstakes.
2. By making a minimum 2018 RPAC contribution of \$99 you are eligible to enter the RPAC Sweepstakes and receive one (1) entry to win one (1) two-year lease for 2018 Toyota Highlander. There is a limit of only one entry per eligible contributor.
3. Entries for the RPAC Sweepstakes can only be obtained between 12:01 a.m. on April 1, 2018 through 1:30 p.m. on December 7, 2018.
4. No purchase is necessary to enter the drawing. Only one (1) entry per person for non-contributors.
5. All entries must be received by 1:30 p.m. on December 7th, 2018 by Suburban West REALTORS Association
6. If, for any reason, the sweepstakes is not capable of running as planned, including tampering, unauthorized intervention, or fraud beyond the control of the sponsor, which corrupts or affects the administration, security, fairness, integrity or proper conduct of this sweepstakes, sponsor reserves the right in their sole discretion to cancel, terminate, modify or suspend the sweepstakes.
7. The sweepstakes will consist of one (1) drawing for one (1) two-year lease for 2018 Toyota Highlander .
8. The drawing will be held on December 7th, 2018 at the Suburban West office in Malvern. Each entrant is eligible to win only one prize in this sweepstakes. The winner does not need to be present to win. The prize is non-transferable and cannot be substituted.
