Real Estate Licensure

FOUR STEPS TO A CAREER IN REAL ESTATE

Step 1: Education

Individuals must complete 75 hours of prescribed education in Real Estate Fundamentals (30 hrs) and Real Estate Practice (45 hrs) and an exam must be passed to complete each course.

Step 2: National & State Licensure Exam

Separate from the exams at the end of the Fundamental and Practice classes, the State-required Real Estate Exam must be passed and includes two sections - a general real estate section and a state-specific section.

Step 3: Criminal Background Check

After passing the Real Estate Exam, applicants must complete a Criminal History Record Information Report completed by the state police (completed online). This report must be dated within 90 days of application.

Step 4: Licensure Application

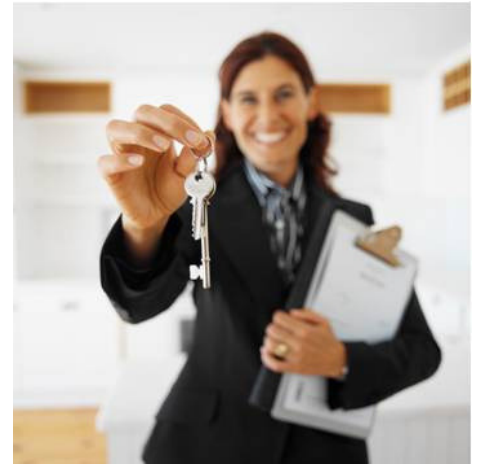
Lastly, applicants must complete the PA Salesperson Initial Standard License Application via the PA Commission's PALS online system and enclose payment, PSI Exam transcript, the Criminal History Report and have affiliation with a PA Real Estate Broker.
